

Terms and Conditions of Entry

Alcohol Harm Prevention Survey - Competition

1. The 'Alcohol Harm Prevention' survey and Competition is run and managed by the Social Planning Team on behalf of Manningham City Council, 699 Doncaster Road Doncaster Victoria 3108 (**Proponent**).
2. Entry into the Competition is deemed acceptance of these Terms and Conditions of Entry.
3. Failure by the Proponent to enforce any of its rights under these Terms and Conditions of Entry at any stage, does not constitute a waiver of those rights.
4. The Proponent may disqualify any entrant deemed not complying with the Terms and Conditions of Entry and the Entry Requirements.
5. Entry to the Competition is achieved by:
 - a. submitting to the Proponent a completed Alcohol Harm Prevention Survey; and
 - b. at question 11 of the Alcohol Harm Prevention Survey, providing a full name and valid email address,during the Promotion Period.
6. If an entry does not include a completed Alcohol Harm Prevention Survey, a full name and/or a valid email address, the entry will be invalid.
7. By entering and participating in the Competition, the entrant agrees to hold harmless the Proponent from and against any and all claims, demands, liability, damages or causes of action (however named or described), losses, costs or expenses, with respect to or arising out of or related to (i) the entrant's participation in the Competition, or (ii) entrant's acceptance of a prize and/or use or misuse of a prize (including, without limitation, any property loss, damage, personal injury or death caused to any person(s)).

10. Individuals under the age of 18 must ensure they have permission from a parent and/or legal guardian before submitting their entry.
11. Manningham City Council staff, contractors and Councillors are not eligible for entry to the Competition.
12. Entry to the Competition is free.
13. Entry to the Competition is voluntary. The Survey can be completed without entering the Competition.

ENTRY REQUIREMENTS

14. Identical entries, where the same valid email address is submitted across different survey responses, will only count as one entry into the prize draw.
15. All Competition entries will be reviewed by a Council Officer for compliance with the Entry Requirements.
16. Entries deemed by the Proponent, in its sole discretion, to be in breach of the Terms and Conditions of Entry or the Entry Requirements, will be disqualified from the Competition without further notice.

WINNER DETERMINATION & PRIZE INFORMATION

17. There will be a total of two (2) winners who will each receive one (1) Coles gift voucher valued at \$100.
18. There is a total prize pool of \$200 for this Competition.
19. On Monday 17 July 2023 the Proponent will randomly select the 2 winners from the valid entries received and on Monday 17 July 2023 will contact each of the 2 winners via their email addresses provided in their entry (**Notification Email**).
