\* If you are the owner of a RESTRICTED BREED DOG (RBD): Dogo Argentino, Fila Brasileiro, Japanese Tosa, American Pit Bull, Pit Bull Terrier and Perro De Presa Canario, the Domestic Animal Act 1994 now requires the owner of these breeds to notify Council that they are the owner of a RBD. Failure to declare ownership of a RBD may incur a penalty. The requirements of an owner keeping a RBD are available at Council.

An Additional Animal permit may be required to house multiple animals on your property dependent on your land size. For further information please visit the Manningham website or call 9840 9333.


