

COMPETITION – TERMS AND CONDITIONS

1. NAME OF COMPETITION:	2025 Manningham Asian Cultural Festival Survey
2. PROPONENT RUNNING THE COMPETITION:	Manningham City Council, ABN 61 498 471 081 of 699 Doncaster Road, Doncaster Victoria 3108.
3. COMPETITION PERIOD:	The Competition begins at 10am AEDT on 9 March 2025 and entry into the Competition closes at 11.59pm AEDT on 23 March 2025.
4. ELIGIBILITY:	<ul style="list-style-type: none"> (a) Individuals under the age of 18 must ensure they have permission from a parent or legal guardian before submitting their entry. (b) Entry is only open to Victorian residents; (c) The Proponent’s employees, contractors, Councillors and family members of these groups are not eligible to enter the Competition. (d) The Asian Business Association of Whitehouse and its employees, contractors and family members of these groups are also not eligible to enter the Competition.
5. ENTRY REQUIREMENTS:	During the Competition Period, an Eligible Entrant must fully complete all fields on the survey and submit the survey to the Proponent in accordance with the Proponent’s directions.
6. MAXIMUM NUMBER OF ENTRIES:	One entry per Entrant.
7. JUDGING:	<ul style="list-style-type: none"> (a) This Competition is a game of chance. (b) All Eligible Entrants who complete the Entry Requirements during the Competition Period will be entered into the Competition prize draw. (c) On Friday 28 March 2025 ten (10) winners will be randomly selected from the prize draw. (d) Each of the 10 Winners is eligible for one (1) prize only. (e) The draw is final and no correspondence will be entered into once the final selection has been made.
