

## **COMPETITION – TERMS AND CONDITIONS**

1.	NAME OF COMPETITION:	2025 Manningham Asian Cultural Festival Survey

3.	COMPETITION PERIOD:	The Competition begins at 10am AEDT on 9 March 2025 and entry into the Competition closes at 11.59pm AEDT on 23 March 2025.
4.	ELIGIBILITY:	<ul> <li>(a) Individuals under the age of 18 must ensure they have permission from a parent or legal guardian before submitting their entry.</li> <li>(b) Entry is only open to Victorian residents;</li> <li>(c) The Proponent's employees, contractors, Councillors and family members of these groups are not eligible to enter the Competition.</li> <li>(d) The Asian Business Association of Whitehouse and its employees, contractors and family members of these groups are also not eligible to enter the Competition.</li> </ul>
5.	ENTRY REQUIREMENTS:	During the Competition Period, an Eligible Entrant must fully complete all fields on the survey and submit the survey to the Proponent in accordance with the Proponent's directions.
