- Photographs of the existing building, structure or place, and trees and gardens.
- A plan of the proposed works, including a colour palette if painting is proposed.
- Any other information that helps describes your proposal.
- Itemised quotes based on the following cost of works:
 - One quote: works under \$3,000
 - Two quotes: works between \$3,000 & \$5,000
 - Three quotes: works over \$5,000

Conditions of the Heritage Restoration Fund 2025/2026

The Heritage Restoration Fund 2025 – 2026 is subject to the following conditions. Failure to comply with these conditions may result in your approved funds being withheld.

- Approved funds must only be used to finance the works that have been approved in your application.
- Approved funds may be subject to conditions (see **Note**), which will be provided in your letter of approval. Conditions must be complied with to the satisfaction of Council officers before your funds are released.
- Approved funds will only be released following the completion of the approved works. To claim your funds, please submit a completed Claim Form and all necessary information demonstrating compliance with the conditions of approval.
- Approved works and the claiming of funds must be completed by the date specified in your letter of approval.

Note - A condition of approval may require that a planning permit be obtained before the approved works commence. If you are required to obtain a planning permit, please contact the Statutory Planning Unit on 9840 9471 to discuss all planning application requirements. It is recommended they are contacted immediately after you receive the approval letter under the Heritage Restoration Fund 2025 – 2026 to avoid delays.
