

# Candidate Election Campaign Donations Return 2016

The Local Government Act 1989 requires a person who was a candidate in a Council Election to give an election campaign donation return to the Chief Executive Officer.

An election campaign donation return must contain details about any gifts received by the candidate or on behalf of the candidate during the donation period to be used for or in connection with the election campaign.

It must state the amount or value that is equal to or exceeds the gift disclosure threshold including the amount or value of goods or services.

The following tables are a summary of the election campaign donations of candidates at the October 2016 Council Elections by Ward.
