The MLDAG plays a role to advise and support Council to deliver actions of the *A Dementia-friendly City Local Dementia Alliance Group Action Plan 2020-2022* and provide support and include people living with dementia and their care partners. The membership of the MLDAG consists of those with a lived experience of dementia, organisations and groups that support people in Manningham living with dementia. Manningham Council has received recognition from Dementia Australia in July 2021 as "Working toward dementia-friendly organisations" status. This demonstrates a strong commitment to ongoing staff awareness and education to create advocacy and ongoing practice improvement.

#### What can you do to support?

The Manningham Local Dementia Alliance Group is seeking new membership and strongly encourage people living with a diagnosis of dementia (and their care partner) to nominate to ensure that the views and needs of people living with dementia are heard and understood. Nominations will also be accepted from residents, community organisations, sporting clubs, local businesses, service clubs, faith groups and other bodies interested in creating a more inclusive dementia friendly community.

We want to ensure the voices of people living with dementia and the organisations supporting them, are actively involved in and contributing to the (MLDAG). The work of the (MLDAG) will play a key role to help guide Council to deliver actions and initiatives that will help foster positive change for Manningham residents living with dementia.

- Demonstrate a mix of skills and attributes to complement other members of the committee
- Have the ability and capacity to regularly attend and participate in meetings as scheduled.
- Who have a lived experience of dementia and demonstrated ability to participate in, and contribute to a committee with a focus on dementia

For those with a lived experience of dementia, assistance is provided if requested to support you to actively participate in the Manningham Local Dementia Alliance Group.

#### **Organisational Representatives**

- Your organisation provides services within the Manningham municipality or has a demonstrated connection to the municipality through professional, technical or industry
- Your organisation demonstrates commitment to dementia friendly communities, health promotion and/or preventative health for older adults
- Your organisations understands the role of local government in healthy ageing
- Demonstrate that you would bring a mix of skills and attributes to complement other members of the committee
- Have the ability to regularly attend and participate in meetings as scheduled.

#### Commitment required

The Manningham Local Dementia Alliance Group will meet bi monthly on the second last Wednesday of each month (six meetings per year).

Successful nominations will be confirmed and contacted by Monday 25 October 2021 with the first meeting scheduled for Wednesday 17 November 2021
